

Agenda 2030 / UN Sustainable Development Goals (the public-facing tiles)

- **SDG 16.9:** “By 2030, provide legal identity for all, including birth registration” → translated: universal digital ID tied to everything you do
- **SDG 11:** “smart/sustainable cities” → translated: 15-minute cities, sensor grids, constant tracking
- **SDG 13:** climate action → translated: carbon wallets, social-credit style limits on travel/meat/energy
- **SDG 3.8:** universal health coverage → translated: vaccine passports were the trial run, health data merged into the same digital ID
- **SDG 17.17:** public-private partnerships → translated: government + BlackRock/Vanguard + Big Tech run everything together (what people call “fascism with extra steps”)

The American rollout the last 5 years (the tiles that got slammed on the table)

2020-2022

- **COVID passports / vaccine mandates** → first mass-scale digital health ID in the West
- **Contact-tracing apps** + Apple/Google exposure notification API baked into every phone
- **Census 2020** + American Community Survey went hyper-detailed on household energy use, commuting habits, income sources (carbon footprint baseline data grab)

2023-2025

- **Federal “Digital Identity” push:**
 - Mobile driver’s licenses (mDL) now live in Arizona, Louisiana, Georgia, Maryland, Utah, Colorado, Connecticut, etc. TSA already accepts them.
 - **IRS Direct File + Login.gov requiring facial recognition (ID.me)** to even file taxes
 - **FedNow (July 2023)** + real-time payment tracking, every transaction visible to the fed in real time
- **Central Bank Digital Currency groundwork:**
 - 130+ countries testing CBDCs, Fed’s “Project Hamilton” & Boston Fed papers openly talk programmable money
 - **Executive Order 14067 (2022) still active**, directing agencies to research digital dollars with expiration dates, spending limits, geo-fencing
- **Smart Cities / C40 org (100+ US cities signed on):**
 - LA, NYC, Houston, Austin, etc. locking into “climate mandates” that mirror C40’s 2030 targets: 0 kg meat, 3 new clothing items per year, zero private vehicles
 - **NYC congestion pricing (2024) + LA’s “mobility wallet” pilots** = pre-loaded carbon allowance apps

- **Social credit line:**

- **ESG scores** now determine corporate loans (banks literally won't lend if your score is too low)
- PayPal, Venmo, GoFundMe, banks de-banking people for wrong think (Canada truckers dry run, now happening quietly in US)
- **X, Facebook, TikTok “trust scores”** feeding directly into advertising profiles that insurers and employers can buy

- **5G + IoT explosion:**

- 250,000+ new **small-cell towers** starting in 2020, every streetlight, sidewalk, trash can become a surveillance node
- **Ring/Nest/Nextdoor partnerships** with police = warrantless camera access nationwide
- **License-plate reader networks (Flock Safety)** now in 4,000+ US cities, private company with zero oversight

How tight the alignment is (no gaps, no coincidences)

Agenda 2030 phrase → US reality 2025

“**Legal identity for all**” → mDL + IRS facial recognition + REAL ID full enforcement May 2025

“**Smart cities**” → C40 cities + ULI “15-minute” zoning laws spreading like wildfire

“**Climate action**” → NYC/LA carbon wallet pilots + Biden’s methane fee + EV mandates

“**Public-private partnerships**” → BlackRock literally writing climate disclosure rules at SEC

“**Leave no one behind**” → “inclusivity” used to justify merging health, finance, travel data into one profile
