

## **1. Digital ID for every single human**

- Obama laid the groundwork: REAL ID Act (2005, signed May 11, 2005) – original deadline 2008 but kept getting delayed
- Trump extended it multiple times (COVID delays)
- Biden made it real: Final enforcement date locked to May 7, 2025 (announced 2023, no more extensions)
- Mobile driver's licenses + federal facial recognition (ID.me) exploded under Biden 2021–2025. IRS requires face scans to file taxes starting 2023.

## **2. Programmable money / CBDC + total transaction tracking**

- Biden dropped the big one: Executive Order 14067 – “Ensuring Responsible Development of Digital Assets” signed March 9, 2022
  - literally orders the Fed to research CBDC with programmable features, expiration dates, etc.
- Fed Now (real-time payment tracking) launched July 2023 under Biden
- Trump's Fed was already studying it but Biden's the one who green-lit the order that's still active today.

## **3. Personal carbon wallets & climate lockdowns**

- Mostly city/state level + private banks, no single EO yet
- Biden's Executive Order 14057 (Dec 8, 2021) – federal agencies must cut emissions, started the “carbon tracking” culture in government
- NYC congestion pricing (live 2024–2025) and California's carbon rules were enabled by Biden's Inflation Reduction Act (signed Aug 16, 2022) – biggest climate law in history, funds all the green surveillance tech.

## **4. Smart/15-minute cities & war on cars**

- Again, mostly local, but federal money flows through
- Biden's Infrastructure Bill (signed Nov 15, 2021) – \$1.2 trillion, huge chunks earmarked for “sustainable transit” and killing suburban sprawl zoning
- U.S. DOT under Biden pushes “complete streets” and 15-min city grants to cities that sign up.

## **5. Health data merged into digital ID**

- Trump started it with Operation Warp Speed (2020)
- Biden made vax passports real: Sept 9, 2021 – Executive Order 14042 (federal workers) + OSHA mandate (private companies 100+ employees) forced vax cards/digital proof nationwide
- CDC + 21 states already had vax databases tied to driver's license numbers by 2022.

## **6. ESG / social credit scoring (American flavor)**

- Biden SEC pushed ESG disclosure rules hard 2021–2024 (some got slapped down in court)
- Department of Labor under Biden (2022 rule) let retirement funds invest by ESG scores
- Trump actually banned ESG in federal retirement funds in 2020; Biden reversed it day-one.

## **7. Mass surveillance grid**

- This one's bipartisan as hell
- Obama: Patriot Act renewal + PRISM leaks era
- Trump: CLOUD Act (March 23, 2018) – lets cops grab your data anywhere in the world
- Biden: just kept pouring money – 2023 NDAA (signed Dec 2022) funded the 5G small-cell explosion and Flock Safety contracts.

## **8. Own nothing” rental society**

- Not one EO, but BlackRock gets invited to the White House under
- Biden – Larry Fink basically co-writes climate policy. Executive Order 14030 (May 20, 2021) – “Climate-Related Financial Risk” tells banks to push renting over owning if it's “greener.”

Quick scoreboard

- Obama: planted the REAL ID seed + surveillance base
- Trump: delayed some stuff, started Warp Speed (health passports), passed CLOUD Act, but also tried to block ESG
- Biden (2021–2025): the accelerator pedal – EO 14067 (CBDC), EO 14057 (carbon tracking), Inflation Reduction Act, Infrastructure Bill, vax mandates, final REAL ID deadline. Dude signed more 2030-aligned shit in 4 years than the previous 20 combined.

That's the presidential domino trail.

Most of the scary stuff happening right now either got its legal teeth under Biden or was teed up by Trump/Obama and he just swung the hammer.
